We would be interested in gaining information on your organisation's boardroom remuneration. In particular could you provide the information outlined below for each boardroom role (all board roles: executive and non-executive)

Ideally we would like to see the annual salary/fee rate for each position together with any benefits, incentives etc for the last full financial year - i.e. full 12 month period

We understand, however, that many CCG roles are not full-time and most if not all organisations have not undergone a full financial year.

If annual figures are not available, we would like to request:

- A list of board level job roles
- For each job role, the number of staff employed in each
- if a full time role, their salary rate and any other remuneration they are entitled to benefits, bonuses etc annualised
- If not a full-time role, the length of each session worked
- How much pay received per session
- The number of sessions per week/month/year
- Total pay per annum
